On Thursday February 25, 2021 more than 50 alumni and friends joined the Real Estate Center Market Trends in Commercial Real Estate and Covid 19 discussion.

The UCONN alumni panel, moderated by **Christine Elmore**, TA Realty, highlighted the impact of Covid 19 on the real estate markets and disruption to rhythm and pace of life impacts. According to
