

Remembering Dr. John Harding

John Harding passed away on March 21, 2024. Harding was Professor of Finance and Real Estate at the University of Connecticut from 1996 to 2013 and is remembered as a dedicated



scholar and teacher who loved the work. He joined academia after a notable career in Finance to exercise his brilliant mind and convey his passion and rigor to his students. In the classroom, he was deeply respected for the depth and relevance of his thinking about banking, mortgage and bond markets and had an ability to inspire. He leaves an enduring legacy in the fields of finance and real estate. John always had a warm smile and was engaging, honest, and respectful to everyone he met. His students and colleagues truly enjoyed every interaction and conversation.

As a member of the board of directors for HonFed Bank and Western Federal Savings andLoan, Harding steered financial institutions. His contributions at Freddie Mac, H.F. Holdings, the Federal Reserve Board, National Permanent Bank and Fannie Mae were pivotal in guiding policy decisions, influencing markets, and fortifying institutions.

John attended Northwestern University, the University of Chicago and the University of California at Berkeley. He received the prestigious Ackerman Award for research excellence twice. The Weimer School Post Doctoral Award recognized his diligent pursuit of knowledge, while the AREUEA Outstanding Dissertation Award celebrated his groundbreaking research.

Dr. C.F. Sirmans



A remarkable scholar who made a significant impact on the fields of real estate, finance, and housing, passed away on March 25, 2024. C.F. Sirmans led the UConn Center for Real Estate to worldwide prominence as Director from 1991–2008, was the William N. Kinnard, Jr. Professor of Real Estate and Finance, and served the School of Business as Interim Finance Department Head, Associate Dean, and Interim Dean. In 2005 he was honored by UConn as a Board of Trustees Distinguished Professor. Thousands of UConn undergraduate, MBA and PhD students were directly impacted by C.F.. He is remembered as generous and collaborative and leaves a strong legacy at the University of Connecticut.

Sirmans attended Valdosta State College and the University of Georgia, receiving a master's degree in economics and a Ph.D. in real estate and urban development. Sirmans specialized in real estate finance and investment, focusing on the understanding of pricing, investment strategies and market dynamics. He is considered by many, the most prolific real estate researcher of his time with well over 300 publications and more than 17,000 citations. He was editor for numerous journals and three seminal textbooks. In addition to his years at UConn, C.F. held positions at Clemson, University of Illinois, University of Georgia, Louisiana State University, and Florida State University; and visiting positions at the Swedish School of Economics and Business, National University of Singapore, University of Hong Kong, City University of Hong Kong, and Brigham Young University.



Cohen has served as a Visiting Scholar with the Federal Reserve Bank of St. Louis and is currently a Research Fellow at the St. Louis Fed's Institute for Economic Equity.

Cohen's work has been supported by various federal and state government agencies, non-profits, and institutions such as the U.S. Department of Transportation, the Lincoln Institute of Land Policy, the Robert Wood Johnson Foundation, and the OECD. He has published over 50 peer-reviewed journal articles in prestigious outlets, contributing significantly to the understanding of transit-oriented development, housing, and climate change's impact on real estate. Cohen's commitment to academic excellence extends to his teaching roles at UCONN, where he educates undergraduate and MBA students in real estate finance and capital markets.
